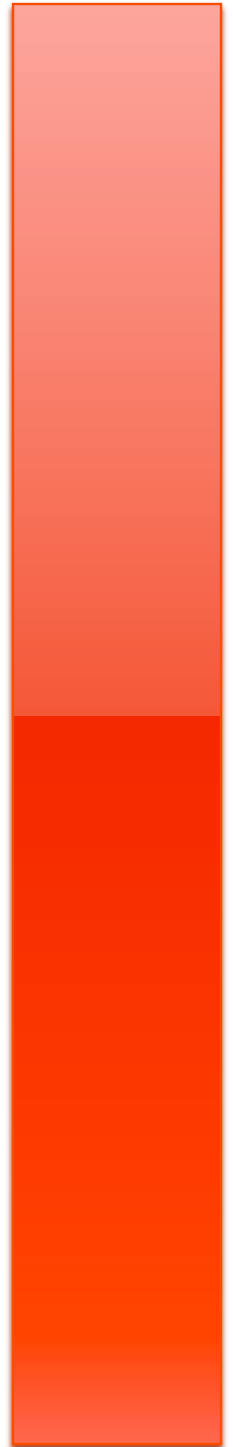

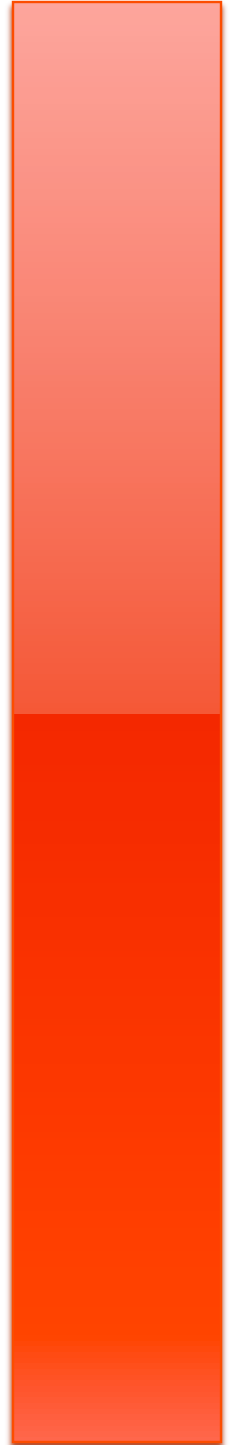

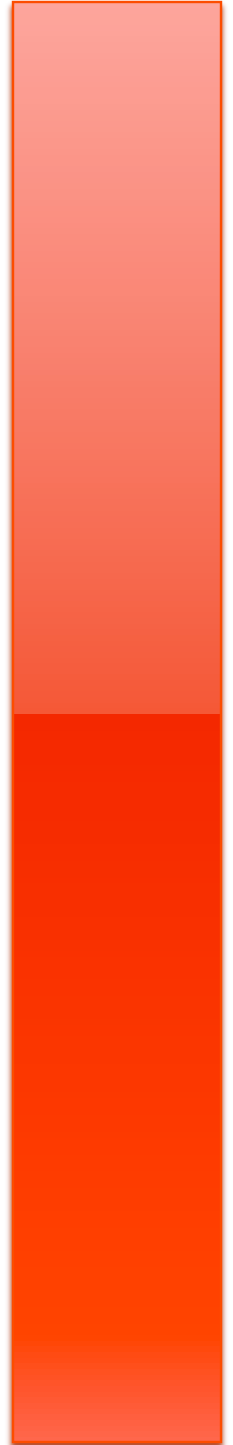
EB-5 INVESTOR QUALIFICATION

- Net worth of us\$1,000,000+
- Or income in excess of us\$200,000+ in previous 2 years
- Five years of tax returns (verifiable)
- Verification that invested funds have been legally acquired
- Lawful personal history/ No criminal record



USCIS EB-5 REGIONAL CENTER PROGRAM

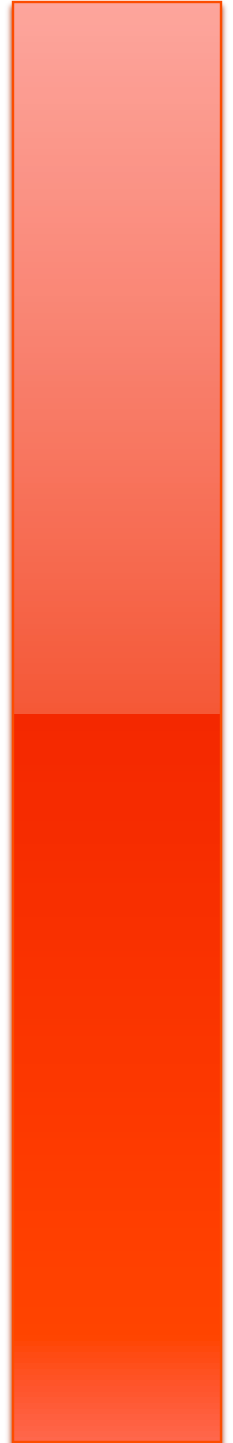
- Exemption to the us\$1,000,000 investment minimum
- us\$500,000 at risk invested in approved Regional Center
- Approximately us\$50,000 legal and administrative fees and expenses
- Investment must create or preserve at least 10 jobs

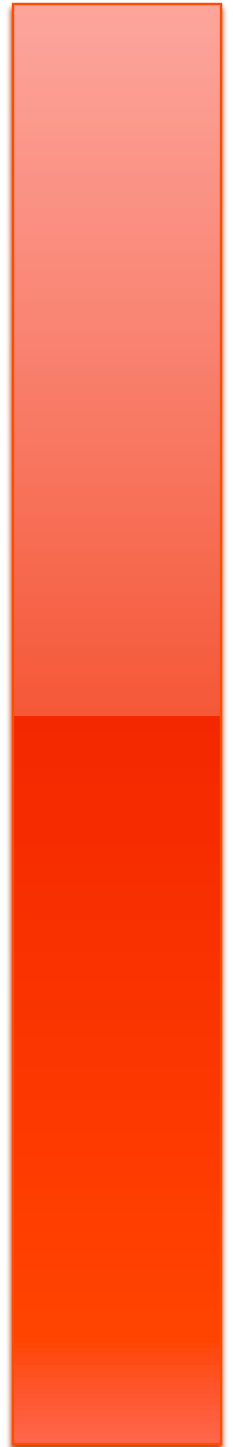
BEHAR LAW GROUP

- ◉ Qualified individuals can invest in approved U.S. Regional Center businesses to obtain U.S. Green Card and all related benefits
- ◉ World Trade Center Fort Lauderdale and Behar Law Group help facilitate the Green Card and citizenship process



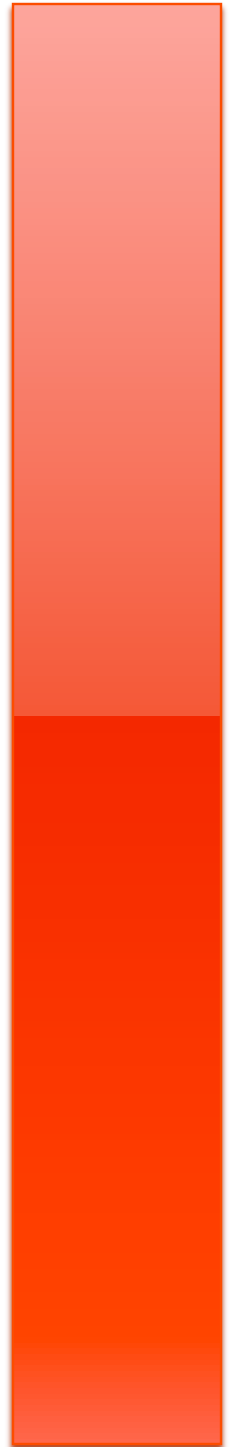
EB-5 BENEFITS

- Green Card for easy travel to and from the U.S.
- Conditional residency can lead to permanent citizenship
- Benefits extend to spouse and unmarried children under 21 years old
- Live and work anywhere in U.S. at least 180 days each year
- Access to U.S. Universities and lower level educational system same as U.S. citizens

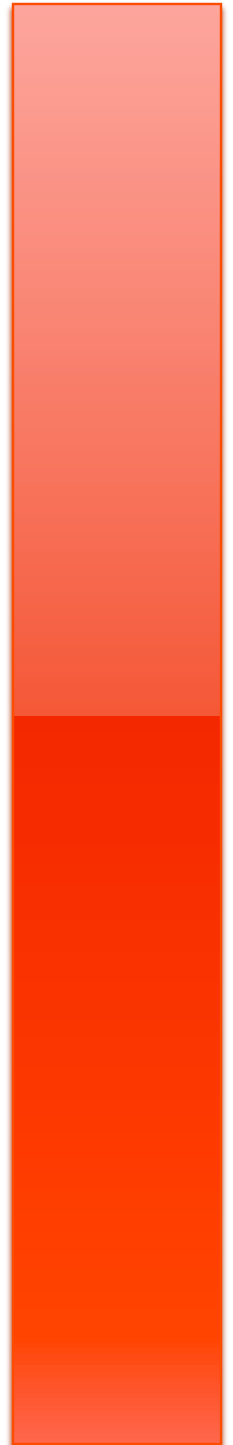

REGIONAL CENTER INVESTMENT OPPORTUNITY

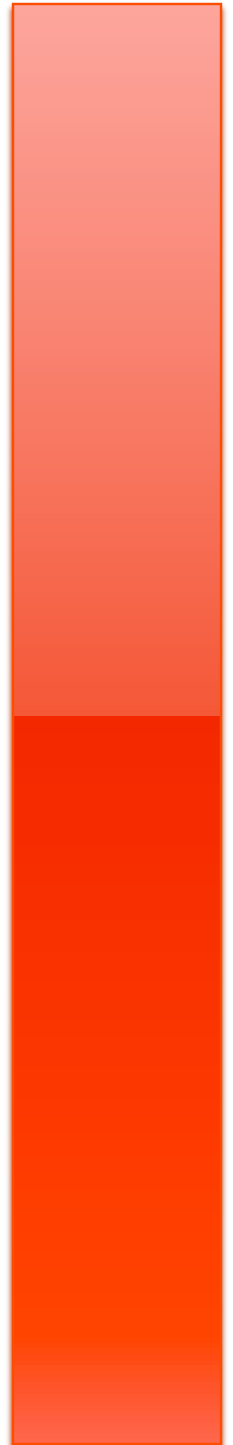
- ◉ Initial questionnaire determines likely acceptance for Green Card
- ◉ Investor selects the Regional Center that matches personal interest and investment goals
- ◉ Each participating Regional Center has been **approved** by the United States Citizenship and Immigration Service (USCIS)
- ◉ Approval process takes approximately 6 months (potential for expedited processing within 2 months)

It is strongly suggested and expected that each investor consult their legal and investment advisor before selecting a Regional Center



WORLD TRADE CENTER FORT LAUDERDALE EB-5 PROGRAM SUMMARY

- ✓ US\$500,000 investment in approved Regional Center
- ✓ Approximately US\$50,000 administrative/legal expenses and fees
- ✓ No day to day management responsibilities
- ✓ Preferred return on investment paid by the Regional Center
- ✓ Established exit strategy to gain return of principle after 5 years
- ✓ Green card for spouse and unmarried children under 21 years old
- ✓ Access to U.S. educational system; Lower tuition at U.S. Universities
- ✓ Plan for permanent residency after 5 years
